UPDATED LEGAL DOCUMENTS

Data protection law is changing and on 25th May the General Data Protection Regulation, known as GDPR comes into effect. GDPR imposes additional obligations on organisations and give you extra rights around how you data is used.

TOPIx Terms and Conditions of Registration and Use

These terms and conditions govern your access to the Jaguar Land Rover Limited TOPIx Online Repair Maintenance Information website www.topix.landrover.jlrext.com (the "Website"), and your use of any technical information and services accessed on it (the "Materials"). By purchasing access or in any manner logging on to or using the Jaguar Land Rover Limited TOPIx website, you agree to be bound by these Terms and Conditions of Registration and Use, together with any matters duly drawn to your attention via the Website during the course of your subscription.

Contractual Agreement

This Agreement is between you, if an individual, your company or business ("You" or "Your") and Jaguar Land Rover Limited (JLR).

This Agreement can be terminated by either party by giving 1 week's prior written notice to the other party. The service may be withdrawn at any time without notice in case of misuse.

- You will fully and accurately complete the online registration form and forward it to JLR. You warrant the accuracy and will be responsible for any loss or damage arising from any inaccuracies

Once you have completed and submitted your registration form and JLR has approved the form and completed the registration process, you will have access to a username / password to enable you to access the Website. JLR reserves the right to refuse to register users or to decline applications. It is your responsibility to keep your username / password secure at all times and divulge it only to those employees or members of your business who have your authority to access the Website. You will be liable for all transactions and costs incurred on the Website under your password. JLR cannot be held liable for any losses you suffer or incur as a result of your failure to keep your username/password secure.
